VII. **NEW BUSINESS**

- A. Discuss the adoption of a preponderance standard for the I-Panel.
 - i. Laura: Cassidy and Ayda are unable to attend but are spearheading this. We will have a full conversation about it when they are here next. But we can start the conversation here.
 - ii. Will: I'll just say that if preponderance is more likely than not and preponderance of the evidence. It ties it more closely to the evidence that the community has. I would be curious if there's a way to do that. Is there a way we can keep the more likely than not standard, and just explain that that's the evidence. If it's essentially the same thing, I would like to just explain it to reps instead of restructure things.
 - iii. Seamus: Two years ago this was the standard and they changed it because it was confusing. But we shouldn't just scrap it. For training and instruction, we

- should abide by the actual definitions. We're looking at confusion versus some small benefits.
- B. Discuss efforts to promote representative elections and raise attendance at Executive Committee elections.
 - i. Laura: Competitive elections helps people develop ideas. We've noticed that in some schools' elections are very competitive but not so in others, including needing appointments. A similar thing for Graves how do we get more people there? We've seen declining numbers, especially if people don't know it happens when they choose to run in general elections.
 - ii. Hannah: For the education school, word of mouth is very effective. I think it's important that the entire school knows this is something they can run for. I don't think people feel connected to Honor in the education school as much, so advertising it more could be useful.
 - iii. Penelope: It really is all word of mouth in the education school. I've had several people reach out asking about time commitment, the role, etc.
 - iv. Carson: Being more clear about what the role is important. Maybe a website page would be useful. In terms of Graves, we could have UBE add a question about their availability there. We can put that on the website too.
 - v. Will: Even if it's not an extra question, we can get the emails for everyone running and tell them about the event. Getting it on the radar as soon as possible. Also a good way to offer everyone a coffee chat.
 - vi. Laura: I can talk to UBE about that.
 - vii. Simran: Using Honor Week as an opportunity to share information about what it means to be a representative.
 - viii. Thomas: Also the newsletter!
 - ix. Carson: The emails of people who attend Honor Week events.
 - x. Ben: Make sure SOs know that elections are upcoming, maybe give them a short spiel. They are more likely to run than the average student. Promoting the SO application widely is also important.
 - xi. Seamus: I think the candidate eligibility quiz closed today. Are there ways to register after the quiz?
 - xii. Will: The way this was explained to me last year, we had an event during Honor Week, you can still file and just have to reach out to them. It's not ideal but could be worth considering.
 - xiii. Laura: How about Representative attendance at Graves?
 - xiv. Will: Making sure people know it's about teambuilding and training, not just elections.
 - xv. Thomas: Problems with timing, hard to get to, etc. Could split it up and/or make it local, would surely improve attendance.
 - xvi. Laura: I was thinking something similar, maybe there's a way to consolidate things down.

- C. Discuss the "Support Officer Dinner Series" idea .
 - i. Laura: A rep or SSO will often take people out to dinner for building community, etc. These can be competitive to get into. What if we catered a dinner up here with catering and an RSVP each month? Could be less intimidating and accessible.
 - ii. Will: That's a really good idea. I wasn't sure where you were going. But I think this is great. Maybe it could naturally lead to them staying here for Committee. If we do it, we should encourage reps to come so it isn't just like a pool meeting.
 - iii. Seamus: I really like the idea. But it shouldn't come at the expense of Committee-SO dinners. Doing anything is better than doing nothing.
 - iv. Will: I want to remind everyone that all reps can still do SO dinners. We want to make that more accessible to other people too.

D. Provide updates on Honor Week.

- i. Laura: Honor Week Recap meeting on February 16. For now I'd like to talk about what we're excited for, challenges we're facing, etc. **We really want your in-person attendance on February 16.** We'll have Roots and talk with the community to recap the week.
- ii. Will: I just want to make sure the student roundtable dinner. We've got 26 CIOs brining seven people each. We'll also bring SOs, etc. We want as many people as possible there.
- iii. Laura: Other important events are the Career Center one, Jeff-Wash debate with an interesting panel of judges.
- iv. Will: This is less of we need staffing, but want to extend an invite to the meet-and-greet before the keynote. There will be past Honor chairs with really cool Honor stories.
- v. Laura: One chair was Thomas Hall, two-time chair. Law alum. Mike Lennox who was an engineer here. It will be a good event with free Stix.
